We have found from experience that students progress further and have more fun in small group lessons with peers. Upon occasion we may ask that a student take a half hour private if necessary. New students might be asked to take a private lesson to properly place them in a class which they will feel most comfortable joining.

Riding Programs - Check the box that applies (Pricing is based on one lesson per week.)

Option #1 – Monthly: Option #1 is paid monthly based on the number of weeks in the month, either four or five and is due the week prior to the month beginning. We do allow for lessons missed to be made up but require they be made up in the month missed.

Hour Group Lesson \$80 (4 Week Month: \$320 / 5 Week Month: \$380)

Option #2 – Trimester: Option #2 is paid on a trimester calendar, and will receive a **10% discount** for any trimester. (\$72.00 per lesson). \$864.00

Each trimester is 12 lessons, lessons must be used within the 12 weeks. We will work with you to fit in make up lessons. It is your (parents) responsibility to arrange make up times. When cancellations are due to the weather the farm will contact you for make up times. Students riding more than 1x per week, multiply trimester price by the number of days riding.

- Lessons will be given every week. If you take additional lessons during or in between trimesters, the cost will be billed accordingly.

We will do our best to accommodate everyone; however, riding days and times are allotted on a first come first serve basis and riding level so that each student can benefit the most from their lesson.

Please be sure to fill out both sheets completely and enclose payment with registration. We will notify you of the lesson schedule as soon as possible.

Important Information:

- All riders must have a properly fitting helmet, boots with a heel and wear long pants. We do realize riding is an expensive sport and children grow quickly, so we do have a small exchange program for apparel that kids have grown out of and do have a few pairs of boots at the barn that may be borrowed.
- Riders should allow 15 minutes before and after their lessons to help tack up, untack and groom the horse.
- **We ask that you provide 24 hours notice for any lesson which will be missed,** so that we can plan accordingly. Lessons which are not cancelled with reasonable notice will not be made up. It is the rider's (parents) responsibility to schedule make up lessons. This rule will be enforced.
- Lessons to include ring work, occasional trail riding, ground horsemanship, medical and barn lessons. We have lessons rain or shine. If we cannot ride indoor, unmounted instruction is given indoors, barn or the learning cottage. No exceptions.
- **NO JEANS!!!** Yoga pants or Proper riding pants only, unless you own your own saddle that has been approved by management for our horses.
